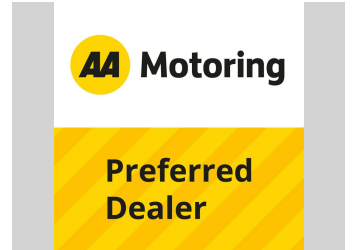



The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$75.22 which equals \$18,636.67.
